**“SPECTRUM INSIDERS RESEARCH PANEL PROMOTION”**  
**OFFICIAL RULES**

**NO PURCHASE IS NECESSARY TO PARTICIPATE IN THIS PROMOTION. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THESE OFFICIAL RULES APPLY TO THE SPECTRUM INSIDERS RESEARCH PANEL PROMOTION (“PROMOTION”) SPONSORED BY CHARTER COMMUNICATIONS OPERATING, LLC. BY ENTERING, YOU ARE DEEMED TO HAVE READ, ACCEPTED AND AGREED TO BE BOUND BY THESE OFFICIAL RULES.**

Online entrant must be the registered subscriber of: (i) the email account and (ii) the Spectrum Insiders Research Panel member. In the event of a dispute as to the entries submitted by multiple users having the same e-mail account, the authorized subscriber of the e-mail account (as specified by the Internet Service provider) used to enter the Promotion at the actual time of entry will be deemed the entrant. Entries made by any individual or any entity other than the named entrant and/or originating at any other Internet Website, including (but not limited to) commercial promotion subscription notification and/or entering service are void.
